1. I further understand that BARKS ON BROADWAY DOGGIE DAYCARE has relied upon my representation that my dog is in good health, meets vaccination requirements, and is not injured. My dog(s) have not shown aggression or threatening behavior to any person or dog. In admitting my dog(s) for services at their facility, I have disclosed to BARKS ON BROADWAY DOGGIE DAYCARE all known risks, dangers, and medical conditions associated with my dog(s).
2. I further understand that BARKS ON BROADWAY DOGGIE DAYCARE, their owners, staff, partners and volunteers, will not be liable, financially or otherwise, for injuries to my dog, myself or any property of mine while my dog is participating in services provided by BARKS ON BROADWAY DOGGIE DAYCARE. I hereby release BARKS ON BROADWAY DOGGIE DAYCARE of any liability of any kind arising from my dogs participation in any and all services provided by BARKS ON BROADWAY DOGGIE DAYCARE.
3. I authorize BARKS ON BROADWAY DOGGIE DAYCARE to take actions they deem as necessary to ensure the health, well-being, and safety of my dog(s), and to take reasonable action to resolve any medical problems that may arise while my dog(s) is/are in their care. I agree to assume full financial responsibility for any and all expenses incurred as a result of the actions of my dog(s). I understand that BARKS ON BROADWAY DOGGIE DAYCARE is expected to make a reasonable attempt to contact me before incurring such expenses, that they may need to incur such expenses if they can't reach me, and that an emergency situation could arise where it would not be feasible for them to contact me before the expense has incurred, including but not limited to first aid, CPR, and/or emergency veterinary care. This authorization includes interventions for any problems with my dog, behavioral, medical or otherwise.
4. I further understand that there are risks (illness or injury) and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by BARKS ON BROADWAY DOGGIE DAYCARE and while in their care. I understand that while the socialization and play is closely and carefully monitored by BARKS ON BROADWAY DOGGIE DAYCARE staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dog will be pointed out by staff upon pick-up. BARKS ON BROADWAY DOGGIE DAYCARE will not be liable for any illness or injury that may occur to my dog(s).
5. I understand by allowing my dog to participate in services offered by BARKS ON BROADWAY DOGGIE DAYCARE I hereby agree to allow BARKS ON BROADWAY DOGGIE DAYCARE to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
6. I further understand that I am solely responsible, financially or otherwise, for any harm or damage (including bedding, walls, etc.) caused by my dog while my dog is attending any services provided by BARKS ON BROADWAY DOGGIE DAYCARE. All charges will be settled at time of pick up.
7. I waive all claims or actions against BARKS ON BROADWAY DOGGIE DAYCARE relating to the care, control, health, and/or safety of my dog(s) arising while my dog(s) is/are in their care.
8. If my pet is here more than five days past the scheduled pick up date, BARKS ON BROADWAY DOGGIE DAYCARE will consider the pet abandoned and will take whatever action is deemed necessary for the continued care of my dog(s). I will pay BARKS ON BROADWAY DOGGIE DAYCARE the cost of any such continuing care upon demand by BARKS ON BROADWAY DOGGIE DAYCARE. I also acknowledge that I will be fully responsible for all attorney's fees and associated costs if I abandon my dog.
9. I understand that BARKS ON BROADWAY DOGGIE DAYCARE is not responsible for food allergies.
10. For the safety of my dog, I understand that only the people listed as my emergency contacts can pick up my dog.
11. No pet will be released until all charges are paid in full at pick up. Late cancellation fees may be applied for reservations cancelled without 24 hours notice.
